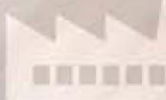
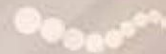

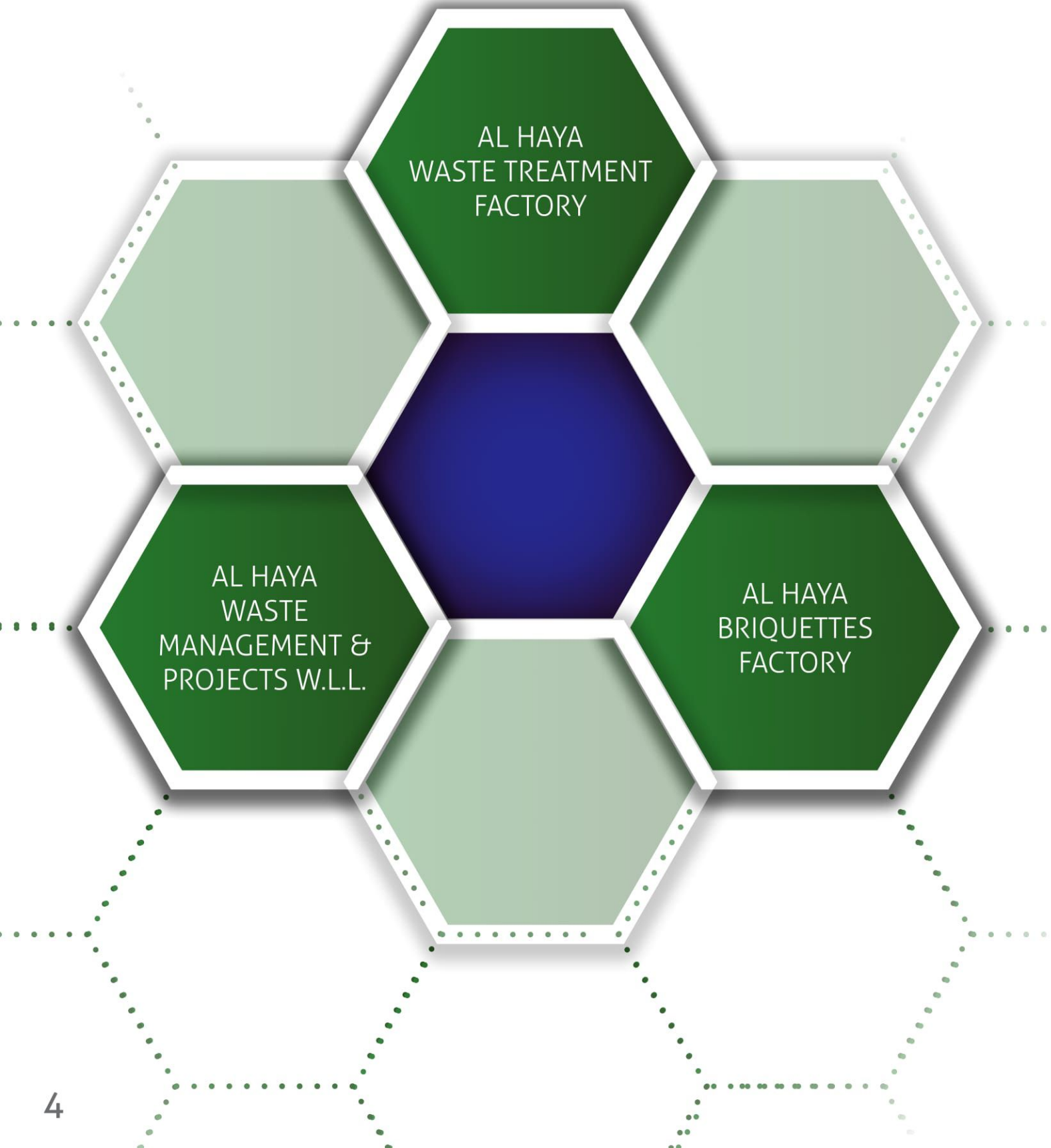

Hazardous Waste Transportation

The company provides Hazardous waste management services to various industries across the State of Qatar. It engages in preparation of necessary documentation in compliance with Basel conventions requirements for exporting waste to Europe and other parts of the world.

Its services include; locating global apt recycling centers for treating various classes of waste, in addition to offering re-packing and export services for Hazardous waste. It is the only company in Qatar licensed to export waste for treatment outside the country complying with Basel conventions requirements. Al Haya Waste Management & Projects has entered into a 5-year contract with Qatar Shell Gas-to-Liquids Limited (QSGTL) to export their waste to Germany.

Electronic Waste Collection

Al Haya Waste Management & Projects has the license for E-Waste Collection in Qatar and provides services to numerous industries & corporations for safe disposal of Electronic Waste. The company has active contracts for collection of electronic waste with more than 60 organizations. 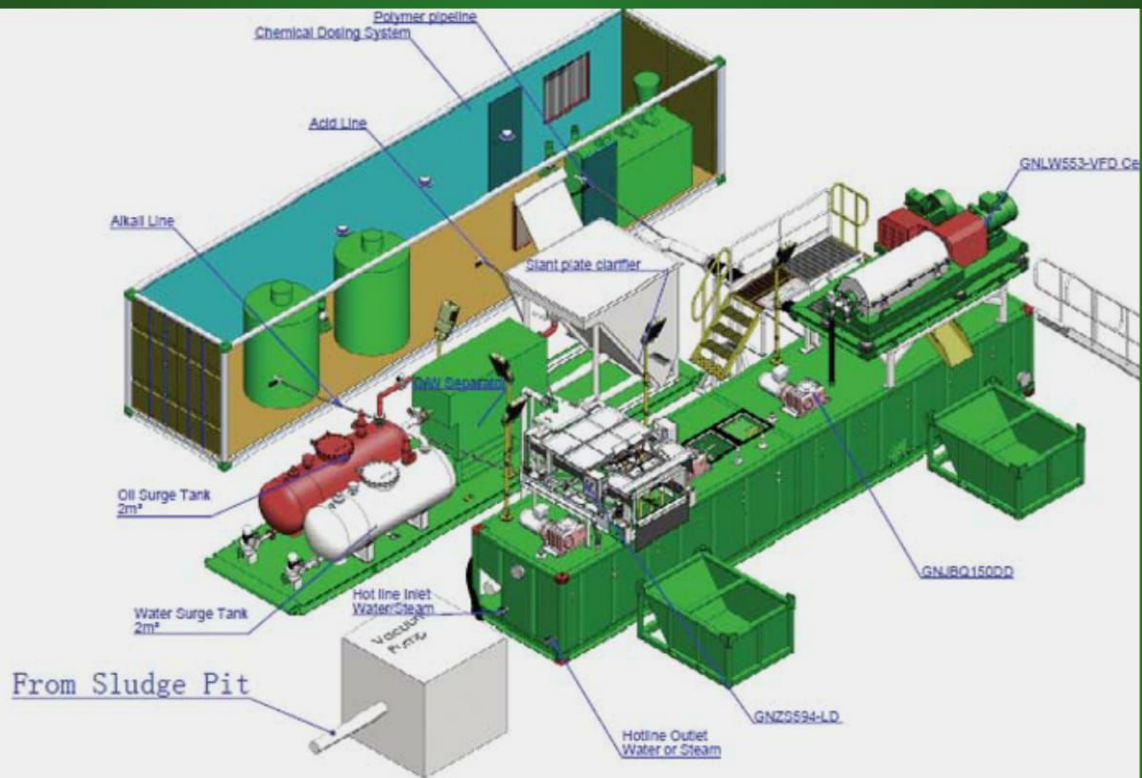

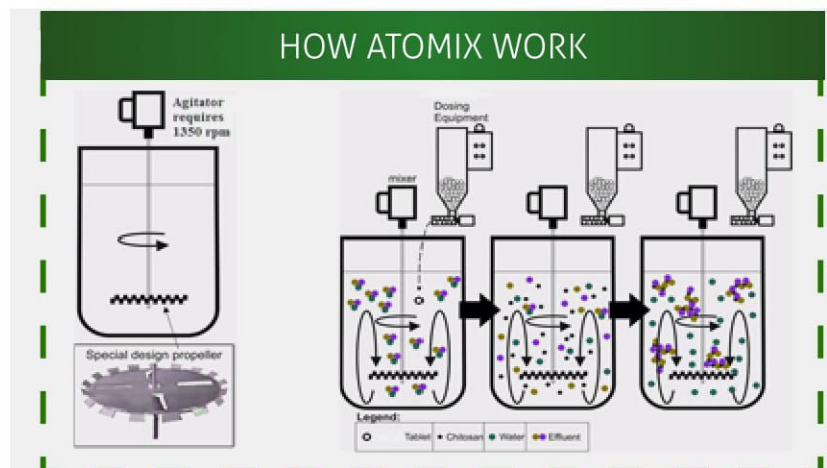
OTHER SERVICES

MARINE SERVICES

AL HAYA WASTE MANAGEMENT & PROJECTS is the approved contractor for collection & disposal of Marpol waste in RasLaffan port & Anchorage. We collect Annex I stream (oily waste) & Annex V (garbage removal) from the ships at Raslaffan anchorage area.



Waste collection and Disposal -

The Company has the capacity to collect the bilge, slops and sludge from shipss as well as crew change. In addition, the Firms' provides the shipping industry by supplying potable water to ships at anchorage since September, 2017.

MARPOL waste reception and separation facility at RasLaffan DRY-DOCK - With it's 1500 ton capacity Marpol waste reception and separation facility at RasLaffan dry-dock, the collected waste oil is separated into oil & water at RasLaffan itself and the separated oil is transport to Measaid for further treatment.



SHIP Tank Cleaning Services -

September, 2017 onwards, the company began it's ship tank cleaning services at RasLaffan on LNG ships. The Firms' Experienced team, provides all consumables and undertakes complete tank cleaning jobs at the Anchorage area.

AL HAYA WASTE TREATMENT FACTORY W.L.L

AL HAYA WASTE TREATMENT FACTORY was registered in the state of Qatar in 2014 with an initial area of 8,000 Sq. Meters.

The Factory is located at Mesaieed Industrial city which is the first of its kind in the GCC to treat solid, semi-solid and liquid waste oils in order to recover the hydrocarbon, which is then exported to be used as fuel in boilers & furnaces. The company has the required technology to treat wax, contaminated grease, and contaminated soil.



AL HAYA WASTE TREATMENT FACTORY has a tie up with a French company which has installed and run several Hazardous waste incinerators in Europe & Middle east for operation of the incinerator project.

The project capacity is contracted with leading oil and gas industries across Qatar, to treat their oily waste and hazardous waste management. The Plant is equipped with necessary water treatment facilities to for treating marine bilge water comprising of a treatment capacity of 24 Ton/day. With the Understanding and appreciation by Qatar Petroleum for the professionalism and capabilities of the factory an additional area of 20,900 Sq.Meters were approved and annexed to the already 8,000 Sq.Meter amounting to a total of 28,900 Sq.Meters. An expansion plan to increase the capacity treatment by 96 Ton/Meter in order to reach a total of 120 Ton/meter will be executed shortly.

Out of the treatment process, the company produces valuable products for other industries, the products of are exported to different countries. The products include

- » Furnace oil Grade 2
- » Semi-refined wax

Al Haya has total area of 28,900 sq.m leased land from QP Mesaieed Industrial city.
